This IPRA award recognizes an individual or organization whose contributions have made a significant and consistent impact on the leisure field and/or profession. To be nominated for this award, the candidate must meet the following criteria: This award is only given at the discretion of the IPRA Board of Directors.

Nominations must be received by FRIDAY, OCTOBER 29, 2010

Primary selection criteria:

- *May be or may have been (but not limited to) elected or appointed to a federal, state or local office, private or not-for profit business organization, member of print or electronic media, or an educator at an accredited institution.*
- *Maintained significant and sustained efforts to provide positive exposure or support of the value of parks, recreation and/or cultural services.*
- *Provided major involvement or sponsorship of leisure activities, events or festivals.*
- *Advocates quality of life experiences as they relate to parks, recreation and/or cultural services with demonstrated success resulting.*

In narrative form, please include the following information for the consideration. The nomination should not exceed five pages.

1. Describe the career activities, accomplishments, offices held and awards received by the nominee as they relate to the field of park, recreation, conservation and/or cultural services.
2. Detail significant and sustained efforts to provide positive exposure of the value of park, recreation, conservation, and/or cultural services.
3. Demonstrate the nominee's advocacy for the quality of life as they relate to park, recreation, conservation and/or cultural services and demonstrate the success resulting from this advocacy.
4. Briefly describe nominee's single most important contribution to Leisure Services in Illinois.

You may want to attach the following in support of the nomination:

- *Resume/Biographical Sketch*
- *Letters of Support*
- *Supportive news clippings, articles, etc.*
